Please note that only PDF versions of papers can be accepted, as the proceedings of CIBB will be produced starting from them.

3 Results

The paper must be formatted single column, 12 pt, on standard A4 paper, and its side edges should be 2.5 cm above, down, left, and right, as shown by this document. The maximum length of the paper is 6 pages.

The references should be cited in this way [1, 2], or also [3, 4, 5].

Software code commands should be written this way:

3.1 Tables and Figures

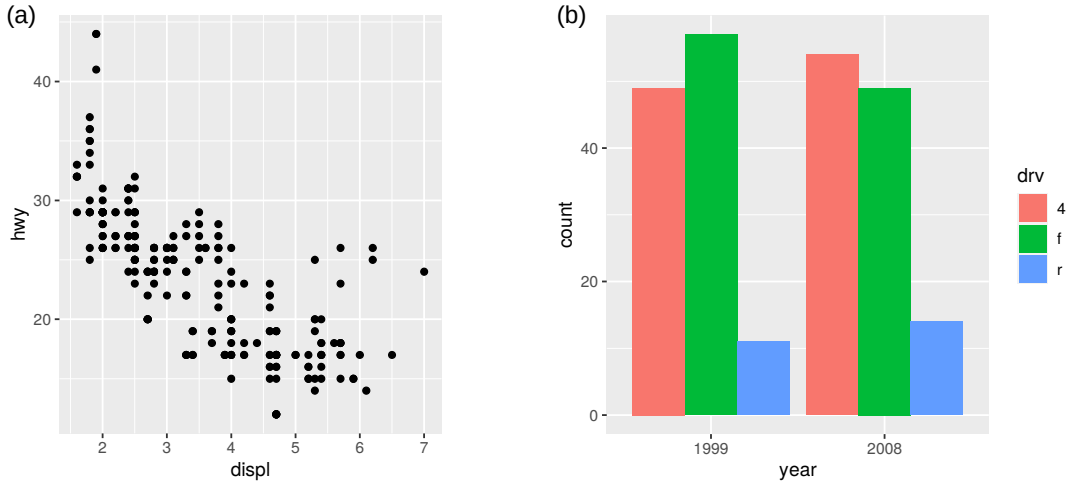


Figure 1: **Example figure.** Please generate your figure images as PDF files and include them here in the article within the text. We suggest you to generate your figures with the `ggplot2` package in R or with `Matplotlib` in Python. Regarding colors, please make sure you use a colorblind palette. This image was generated with `ggplot2` and then edited with LibreOffice Draw.

Tables and figures must be placed in the paper close where they are cited. The caption heading for a table should be placed at the top of the table, as shown in Table 1. The caption heading for a figure should be placed below the figure, as shown in Figure 1.

3.2 Equations

Equations should be centered and numbered consecutively, in this way:
